**Entry gained thru west side gate at 630pm**

**Food and drink allowed, no glass and no alcohol. NO GRILLS ALLOWED INSIDE POOL AREA**

**The Rental party is responsible for leaving clean tables and trash picked up.**

*No diapers, paper products, or blue jean cut offs allowed in the pool; appropriate swimwear is required.*

**SWIM TEST FOR SLIDE - must swim the width of the pool and back without stopping or touching bottom - NON SWIMMERS MUST STAY WITHIN ARM'S REACH OF AN ADULT**

Basketball - **NO** dribbling or shooting from the deck, **NO** dunking or touching the net, keep the ball in the basketball area.

Slide - one at a time, no floatation devices, minimum 48 inches, clear the well quickly, feet first/face up. Slides will be professionally monitored for groups over 50.

Vortex - you must go with the current, no hanging onto the side, **DO NOT** jump in when crowded, **DO NOT** reach over the barrier.

**DO NOT** cross over barriers, stand on barriers, stand on benches                    **NO DIVING**

Lifeguards are on duty to enforce rules and regulations and to assist in emergencies, parents and adult supervisors are primarily responsible for the safety of children and conduct of the children and/or group. Please help remind children to **WALK**, play in appropriate areas, and to follow the safety rules. Direct supervision and visual contact of children under 12 must be maintained at all times.

**OUTDOOR WEATHER PROTOCOL**

We are required to close the pool for a minimum of 30 minutes for lightning within 10 miles. Before the party starts if weather looks unfavorable it is at the parties discretion to reschedule . If they choose to continue with the party and we have to close there are no refunds or rescheduling.
